| <ul style="list-style-type: none"> <li>● To ensure that an educational caring and stimulating environment is provided for children that takes into account individual developmental needs and enables children to reach their full potential.</li> <li>● To plan and prepare exciting play opportunities that meet children’s developmental needs and stimulates their learning and integration within the nursery.</li> <li>● Keep abreast of legislation, guidelines, policies to ensure the Children’s Act and the Early Years Foundation Stage Welfare Requirements are met at all times.</li> <li>● To observe and assess children’s development and keep accurate records of their achievement.</li> <li>● To work with the school to ensure the smooth transition of children to Reception Class.</li> <li>● Work with parents to provide full integration of all children into the nursery.</li> <li>● To help and support students/volunteers on placement.</li> <li>● To establish and maintain positive working relationships with parents/carers in a way that supports children’s learning and development and values parental involvement.</li> <li>● To be flexible within working practices of the nursery e.g. To help, where needed, including undertaking certain domestic jobs within the nursery, preparation of snack meals, cleaning equipment etc.</li> <li>● Work alongside the Manager and staff team to ensure that the philosophy behind the nursery is fulfilled.</li> <li>● Ensure all nursery procedures are followed correctly, e.g. safeguarding, recording of accidents and the collection of children.</li> <li>● Respect the confidentiality of information received at all times.</li> <li>● Undertaking of specific childcare tasks: The preparation and completion of activities to suit the child’s stage of development. To ensure that mealtimes are a valuable social occasion.
